

# Mainland United Soccer Association Waiver and Photo Release

## WAIVER

On my own behalf and on the behalf of participant, my heirs, successors and assigns, as the parent or guardian of the below named child I hereby forever release and discharge and agree to indemnify Mainland United Soccer Association, Linwood Soccer, Members, Partners, Representatives, Officers, and Volunteers and all the representatives (collectively "MUSA" and the "released parties") from any and all injury, damage, loss, demands or causes of action, whether known or unknown ("claims") that I may now or hereafter have arising out of my or participants participation in any "MUSA" related activities. I understand and acknowledge that dangers of personal injury are inherent in participating in soccer try-outs, clinics, practices, camps, tournaments, competitions, or games and I expressly and voluntarily assume all risk related thereto, including without limitation, death or personal injury sustained in the try-outs, clinics, practices, camps, tournaments, competitions, or games as well as the risks incurred in all these activities and those arising from hidden, latent or obvious defects in any facilities or equipment used. I acknowledge the possibility that my successors or I may not fully know the number or magnitude of all claims, and agree that this release is a full and final release of all claims. This release is intended to be binding on my heirs and assigns. This release is being signed in consideration of the opportunity to play in "MUSA" activities and is governed by New Jersey State Law.

## PHOTO RELEASE

I hereby give permission to MUSA to use my photograph or photographic images of my minor child in print or online materials designed for news, promotional, informational or educational purposes related to MUSA official business, including: Web sites, newsletters/flyers and newspapers, etc. It is agreed that the use of my photograph or photographic image shall in no way be used in any other forum other than for official business. I understand that MUSA requires that minor players whose photographic image maybe used in the promotion of MUSA and its departments/units must have a signed photograph release on file. In consideration of engagement as a model, and for other good and valuable consideration herein acknowledged as received, I hereby grant to MUSA and assigns, those acting with its authority and permission, the irrevocable and unrestricted right and permission to copyright, in its own name or otherwise, and use, re-use, publish, and re-publish photographic images of me or my minor child me or which we may be included, in whole or in part, or composite or distorted in character or form, without restriction as to changes or alterations, in conjunction with my own or a fictitious name, or reproductions thereof in color or otherwise, made through any medium at his studios or elsewhere, and in any and all media now or hereafter known for illustration, promotion, art, editorial, advertising, trade, or any other purpose whatsoever. I also consent to the use of any printed matter in conjunction therewith. I hereby waive any right that I may have to inspect or approve the finished product and the advertising copy or other matter that may be used in connection therewith or the use to which it may be applied. I hereby release, discharge, and agree to save harmless MUSA and assigns, and all persons acting under its permission or authority or those for whom acting from any liability by virtue of any blurring, distortion, alteration, optical illusion, or use in composite form, whether intentional or otherwise, that may occur or be produced in the taking of said picture or in any subsequent processing thereof, as well as any publication thereof, including without limitation any claims for libel or invasion of privacy. I do hereby release, acquit and forever discharge the State of New Jersey, MUSA, its officers, employees, attorneys, representatives, insurers and assigns from any and all demands, cause of action and/or judgments of whatsoever nature of character, past or future, known or unknown, whether in contract or in tort, whether for personal injuries, property damage, payments, fees, expenses, accounts receivable, credit, refunds, or any other monies due or to become due, or damages of any kind or nature, and whether arising from common law or statute, arising out of, in any way, the use of my photographic image or photographic images of my minor child for official business. This release contains the entire agreement between the parties and shall be binding upon and inure to the benefit of the successors and assigns of the undersigned.
